Filaria Consultant - ___ Post

Purpose

To strengthen Elimination of Lymphatic Filariasis Programme and support Directorate NVBDCP by conducting Entomological survey and generate data on various entomological indices as per the programme guidelines. The post is of high importance in pursuit to achieve the goal of elimination of Lymphatic Filariasis by the year 2020.

Responsibilities

- Consultant will be responsible for all the entomological and other technical aspects of the disease.
- Development / Revision of entomological/ technical guidelines, collection, compilation and analysis of the data from states, providing feedback and follow-up.
- Conduct regular field visits for ensuring quality implementation of the programme and provide on-spot technical support to the concerned staff.
- To organize/conduct/facilities training and supportive supervision to State/District and grass root level officials.
- Participation in review meetings for providing technical inputs.
- To analyse data, its interpretation and presentation.
- Providing Technical support to programme Officers.
- Any other work assigned by the Regional Director/ or concerned programme officer, Gol.

Qualification and Experience

 M. Sc. Zoology/Life Sciences, preferably with specialization in entomology or PH. D. with 2-3 years experience of working field of Entomology.

Nature of appointment

The appointment of the Consultant will be on contract basis initially for a period up to 31st March 2020 (subject to satisfactory performance) and extendable further on basis of performance.
