TERMS OF REFERENCE

1. Programme Coordinator:

Purpose

To implement the national JE/AES prevention and control programme, assist in monitoring and evaluation, surveillance and information management for JE/AES so as to ensure use of reliable data for decision-making at all levels of the Programme. In addition, liaise with the MOHFW and other ministries as well as state governments for better programme implementation and monitoring including policy changes as and when deemed necessary. Shall work as a technical advisor to the programme.

Responsibilities

Working in close collaboration with NVBDCP officials, staff and other Consultants:

- i. To assist in all technical components of programme formulation and programme implementation.
- ii. To assist in the implementation of the new JE/AES prevention and control programme, to review its status from time to time. To coordinate with consultants at state and district JE Consultants to ensure quality implementation of programme.
- iii. To develop formats, log frame, matrix for monitoring and evaluating the program implementation in collaboration with NVBDCP staff, public health specialist and IT specialist. To develop or refine indicators for the programme.
- iv. To assist in the development of methodology for mid-term evaluation and to ensure they are undertaken.

- ii. To ensure that current Programme Guidelines for planning, training, service provision, monitoring, supervision and surveillance of JE/AES are applied in all health facilities and by all health workers concerned.
- iii. Conduct regular field visits for ensuring quality implementation of the programme and provide technical support to the concerned staff on site, including ongoing on-the job training and supportive supervision to District JE/AES consultants
- iv. To ensure timely data analysis, presentation and interpretation
- v. To supervise the JE/AES control logistics so as to ensure against stock-outs.
- vi. To provide technical support to State Programme Officer (SPO) and guide District VBD Officers, for the preparation of district plans for control of JE/AES
- vii. To actively seek involvement of state administration, NGOs, CBOs and the private sector (health and non-health) under various schemes.
- viii. To assist the SPO and specialized staff in development of the BCC / IEC plan for the state.
- ix. Any other duties assigned by the Director, NVBDCP.
