I am directed to refer to this Directorate's letter of even No. dated 23.04.2013 on the subject cited above and to say that since the Ministry has delegated the power to Sr. Regional Director for one year w.e.f. 09.04.2013 to fill up the live and vacant Group 'C' post on contract basis till these are filled up on regular basis, Action in the matter may therefore be initiated at the earliest to fill up all live & vacant posts.

In order to fill up these posts quickly, it has been decided that aforesaid posts will be advertised locally at the Regional Offices for which these posts are required and walk-ininterviews will be conducted. The Selection Committee to conduct the walk-in-interviews will be formed, consisting of three members, under the chairmanship of concerned Sr. Regional Director (H&FW) and two other members of Section Officer/Under Secretary equivalent level from any other Central Govt. office located in that station.

In respect of posts under NVBDCP& CBHI component, copy of Recruitment Rules, draft advertisement, contractual service agreement and duties of the posts will be made available to all Regional Directors by NVBDCP & CBHI. Since Group 'C' posts under Family Welfare component were already being filled by the Regional Directors, educational qualification etc. as given in Recruitment Rules are available with them. The remuneration for contract employees may be fixed as per the minimum wages notified for each category of post by the respective State Govt.

5. LEAVE

The Signatory shall be entitled to the following sick, annual and /accrued, maternity leave provisions:

- Annual leave to be accrued for one year: 30 days per annum (2 ½ days per month)
- · Sick leave : 10 days per annum
- Maternity Leave equal to 60 days half pay leave

The leave remaining unutilized at the end of the contract shall not be en-cashed.

6. STATUS OF THE SIGNATORY

The signatory shall have the status of contractual employee and shall not be considered in any respect as a regular staff of National Vector Borne Disease Control Programme (NVBDCP).

7. RIGHT AND OBLIGATION OF THE SIGNATORY

The rights and obligations of the Signatory are strictly limited to the terms and conditions of this Agreement. Accordingly, the Signatory shall not be entitled to any benefit, payment, subsidy, compensation or pension from National Vector Borne Disease Control Programme (NVBDCP), as expressly provided in this Agreement.

THE SIGNATORY SHALL NOT BE EXEMPTED FROM TAXATION AS PER INCOME TAX LAWS OF GOVERNMENT OF INDIA AND SHALL NOT BE ENTITLED TO REIMBURSEMENT OF ANY TAXES WHICH MAY BE LEVIED ON THE REMUNERATION RECEIVED.

RESCISSION

Either party may rescind this Agreement at any time by giving the other party, at least 15 calendar days notice in writing of its intention to do so. Compensation may be paid in lieu of notice, which will not be less than one week's remuneration for each unexpired month of the Agreement.

TERMINATION

In case of improper conduct by the Signatory, having regard in particular to Articles 12 and 13, the Director, National Vector Borne Disease Control Programme may terminate this Agreement; no compensation shall be payable in such a case.

10. DESIGNATION OF BENEFICIARY (to be filled by the Signatory)

The Signatory has designated

as her/his beneficiary for all amounts standing to the Signatory's credit under the terms of Agreement in the event of the Signatory's death.

11. TITLE RIGHTS

The title rights, copyrights and all other rights of whatsoever nature in any material produced in the framework of this Agreement shall be vested exclusively with Directorate of National Vector Borne Disease Control Programme (NVBDCP).

12. UNPUBLISHED INFORMATION

The Signatory shall exercise the utmost discretion in regard to all matters of official business. She/he shall not communicate to any person information known to her/him by reason of her/his official position which has not been made public, except in the course of her/his duties or by authorization of the Directorate of NVBDCP. At no time shall she/he in any way use to private advantage information known to her/his by reason of her/his official position. These obligations do not cease with expiry of this Agreement.

13. DISCLOSURE

The Signatory shall disclose to Directorate of NVBDCP any business or professional employment or activity in which he may be engaged prior to or at any time in the course of the present Agreement. These activities shall not be incompatible with the performance of the services outlined under Article 1.

14. PERFORMANCE OF DUTIES AND STANDARDS OF CONDUCT

In the performance of her/his duties her/his Agreement, the signatory shall be exclusively responsible to Directorate of NVBDCP and shall neither seek nor accept instruction from any authority/external agency, unless otherwise specified in Article 1(b).

The Signatory shall not engage in any activity that is incompatible with those purpose and principles or the proper discharge of her/his duties with National Vector Borne Disease Control Programme (NVBDCP). She/he avoids any action and in particular any kind of public pronouncement which may adversely reflect on that relationship or on the integrity, independence and impartially which are required by her/his relationship with NVBDCP.

Any favour, gift or remuneration from any source other than Directorate of National Vector Borne Disease Control Programme (NVBDCP) shall not be accepted unless approval from Director, NVBDCP has been obtained before hand.

15. AMENDMENT

This agreement may be amended by mutual consent between the parties.

SETTLEMENT OF DISPUTES

Any claim or dispute relating to the interpretation of the execution of the present Agreement which cannot be settled amicably or through conciliation procedures shall be settled by arbitration, unless the parties agree on another mode of settlement.

The arbitral panel shall be composed of one member nominated by Secretary (H&FW), Govt. of India (NVBDCP) or his representative as Chairman and one member nominated by the Signatory. The parties shall accept the arbitral award as final.
