The terms of reference of the Cadre Review Committee are given as under:-

- Review the existing cadre strength in all posts including posts in technical and non-technical cadres, in the organization and recommend restructuring of cadres and re-fixing cadre strength, taking into consideration the stagnation level and possibility of merger of different posts/cadres, mobility of personnel from one post to another carrying similar duties and pay scale, abolition of posts which have become redundant or infructuous etc. While recommending the strength in various cadres, the Committee will take into consideration the functional needs, legitimate career expectations of the employees and also assess the financial implications involved and recommend suitable matching savings. Committee will undertake review and restructuring keeping in view the instructions laid down by the Department of Personnel and Training in this regard.
- Recommend appropriate changes in the Recruitment Rules for various posts in the light of the recommendations.
- Any other issue incidental to (a) and (b) above with the consent of Official and Staff side.

The Committee shall submit its report within a period of three months.
